As of the end of the current year, the Institutes information returns filed with the Internal Revenue Service remain open for examination generally for three years after they were filed. The Institute follows the Financial Accounting Standards Board Accounting Standards Codification (FASB ASC), which provides guidance on accounting for uncertainty in income taxes recognized in an organizations financial statements. The guidance prescribes a recognition threshold and measurement attribute for the financial statement recognition and measurement of a tax position taken or expected to be taken in a tax return, and also provides guidance on derecognition, classification, interest and penalties, accounting in interim periods, disclosure, and transition. Examples of tax positions include the tax-exempt status of the Institute and various positions related to the potential sources of unrelated business income tax (UBIT). As of the year end, the Institute had no uncertain tax positions that qualified for either recognition of an unrecognized tax benefit or disclosure in its financial statements. The Institutes policy is to recognize interest and penalties, if any, on tax positions related to its unrecognized tax benefits in income tax expense in the financial statements.
