THERE IS A FINANCE COMMITTEE WHICH OVERSEES THE AUDIT PROCESS AND REVIEWS FINANCIAL STATEMENTS, PRESENTS INFORMATION TO AND MAKES RECOMMENDATIONS TO THE BOARD. THE BOARD VOTES ON THE SELECTION OF AUDITORS AND OTHER RELEVANT FINANCIAL DECISIONS. THERE HAS BEEN NO CHANGE FROM PRIOR YEAR.
