Quality Early Care and Education - Based on research showing the long-term impact on early education, the Partnership focuses on strategies that improve the quality of child care, increase access to child care for low income families and support early childhood teacher education. The Partnership also offers NC Pre-K, a quality pre-kindergarten classroom program for 542 at risk four year olds. The Partnership manages two federal grants to provide full comprehensive Early Head Start services to 172 infants and toddlers (0-3) via two program models, Center-based and Home-based services.

4b (Code: HIFS) (Expenses \$ 850,076 including grants of \$ 802,674) (Revenue \$)
Health, Early Intervention and Family Support - Physical and developmental health is critical to a child being in the best condition to learn. In response to this need, Durham's Partnership for Children invests in a variety of evidence based/evidence informed programs that offer support for parents and child health and developmental interventions. The Partnership funds a continuum of Family Support programming in English and Spanish in Durham County including linking families to community resources, curriculum-based parent education and literacy series, consultation and training on children with challenging behaviors, intensive home visiting programs, case management, and child safety support. Two new literacy programs were implemented to provide books and encourage early literacy to more than 6,000 children through Dolly Parton's Imagination Library and Reach Out and Read.

4c (Code: CDCB) (Expenses \$ 400,630 including grants of \$ 610) (Revenue \$)
Community Development and Capacity Building - The Partnership funds Community Awareness and Education within its Program Coordination and Evaluation unit, both of which focus on Community Development and Capacity Building. The Community Awareness and Education program creates educational materials; develops, manages, and supports public relations activities; and coordinates events in order to build awareness of issues affecting young children and their families. The Program Coordination and Evaluation program conducts technical assistance, monitoring, evaluation, program development, data collection and analysis, and needs assessments in order to achieve program excellence and effectiveness. Several community based initiatives also fall under Program Coordination: Transition to Kindergarten, the Early Childhood Training Institute that includes the Durham Touchpoints Collaborative, the Early Childhood Mental Health Task Force, Durham's Campaign for Grade-level reading, the DELTA Collaborative, and the Collaborative to End Family Homelessness.

Monitoring: The Partnership, in compliance with Federal standards and administrative requirements, provides ongoing monitoring of its operations as well as those of its contracted delegate agency. It is the policy of the Grantee that all programmatic, fiscal, and management areas of the Early Head Start program are regularly reviewed and that appropriate and timely follow-up is provided to ensure correction of non compliance issues. A full monitoring review of the delegate agency is conducted by program and fiscal staff on an annual basis to assess compliance with performance standards and contract requirements. A monitoring tool has been developed using the Office of Head Start Monitoring Protocol and Self-Assessment Booklets. Monitoring includes a review of compliance with Head Start Performance Standards and compliance with the development and implementation of the financial management system. This will include a detailed review of the financial reporting accounting records, internal controls, and budget controls. The Partnership staff reviews program and fiscal data including financial status reports, financial source documentation for expenditures, monthly program updates, Head Start Enterprise System (HSES) reports, ChildPlus reports, year-end report and Performance Information Review (PIR) information. A monitoring report, including scope of testing, any issues noted, and recommendation will be provided to the delegate agency.

Background about the Partnership

Since 1995, Durham's Partnership for Children (DPfC) has created a comprehensive early childhood system that supports collaborative service delivery and planning. DPfC's mission is "To ensure every child in Durham enters school ready to succeed, we lead community strategies for children birth to 5 and their families that promote healthy development and learning and enhance access to high quality care."

The Partnership has formed strategic alliances within various sectors including government, business, medical, faith and education to integrate evidence based practices and measurable results.

DPfC is one of 75 local Partnerships in North Carolina. It is the leader charged with implementing North Carolina's Smart Start Initiative, NC Pre-Kindergarten Programs for Durham County, and Durham Early Head Start. In FY 17-18, DPfC funded 10 Smart Start programs 38 NC Pre-Kindergarten classrooms, and Early Head programs with both center based and home based components.

Additionally, DPfC leads the Durham Touchpoints Collaborative, which is the hub of the Early Childhood Training Institute, (ECTI), and the Transition to Kindergarten Initiative. Touchpoints trains providers from across disciplines to provide a strengths-based common language for working with families during times of vulnerability. The ECTI also provides training in Family Connections, Racial Equity, and Toxic Stress and poverty. Transition to Kindergarten engages a variety of community stakeholders to plan and implement transition activities for rising kindergarteners and families throughout Durham. Collaborative work includes DELTA, Ending Family Homelessness, Campaign For Grade-level reading, and the Early Childhood Mental Health Task Force.
