North Carolina Pre-Kindergarten (NC Pre-K) - A high quality pre-kindergarten program that serves children who are at risk and prepares them for success in school. Pre-kindergarten is a research-proven strategy for school readiness and provides educated teachers, small class sizes, low teacher-child ratios, research-based comprehensive curricula, and a focus on the whole child and family. 668 children were served during the year.

4b (Code:) (Expenses \$ 350,531 including grants of \$ 5,766) (Revenue \$ 10,968)
Child Care Resource and Referral (CCR&R) program promotes quality child care and ensures that children acquire the skills to succeed in kindergarten. This program provides services to ensure that safe, high-quality, affordable child care is available; comprehensive consumer information on child care choices, parent support and training; capacity building, technical assistance, trainings, professional development and provider recognition and accomplishments. During the year, the achievements of this program include the following: 97 trainings provided to child care providers, 330 providers trained and 96% of providers exhibited an increase in knowledge based on pre and post-test scores, 9 facilities received on-site technical assistance to increase their star rating, 31 facilities received technical assistance to maintain their star rating, 871 instances of intense technical assistance were provided to child care professionals.

Parents As Teachers (PAT) program provides monthly home visits to children and their parents/guardians to promote optimal early development through enriched learning experiences. The program teaches parents that they are the child's first teacher. Parent educators use developmentally appropriate activities to engage families while reaching social, emotional, transitional, and cognitive goals. 700 home visits provided to 75 parents/guardians; 50 families referred to community resources, 35 families attended 16 playgroups, 49 children received developmental screenings.
