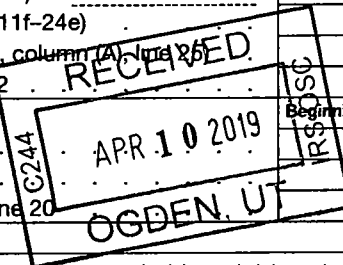

Musiqqa is led by four Houston composers and community leaders to enrich and inspire the community, including youth programs, that integrate contemporary new music with other art forms. With its innovative collaborations and educational programming, Musiqqa strives to make modern classical repertoire accessible and vital to all audiences and musical backgrounds.

Public Performances - Musiqqa performed three concerts at the Houston MATCH facility and an additional at the Zilkha Hall, Hobby Center, Houston, Texas. Each concert included at least one world premiere work by Musiqqa composers and visiting artists from around the United States.
Additionally, three free concerts were performed in the Contemporary Arts Museum of Houston in conjunction with changing art exhibits and a free concert at the Lawndale Art Center in collaboration with ROCO, Inprint and the Lawndale and Hispanic Forum.

Educational Performances- Musiqqa provides free outreach programming for at-risk children in the area public schools. Programs are performed for approximately 6,000 students at the Zilkha Hall, Hobby Center, Houston, Texas which expose students to musical elements and cultural diversity. The students als are instructed and participate in free in-school preparatory workshops to enrich the performance programs. The programs include musical instruction along with foreign language instruction, music appreciation and exposure to the cultural arts.
Additionally, about 200 students participated in the in-school residency program with Musiqqa teaching artists. The curriculum for these residencies was designed in collaboration with the schools as a supplement to the academic curriculum and otherwise unavailable to the regular student programming.
