Site visits are conducted on a regular basis to review an organization and its programs, especially if an organization is new, or if the organization has not previously been awarded a grant from CFCG. Telephone inquiries are also made on a regular basis to obtain current information on the organization as part of due diligence. Prior to funds being disbursed to a potential grantee organization, requests for disbursement must be approved by the Executive Committee or the Board of Directors of CFCG. After approval, grantees receive their grant payment along with an award letter specifically stating how the funds are to be used. Final reports on how the grant funds were used are required for all grants from competitive grant-making programs. Final reports may also be required for any grants from a donor advised, organizational endowment, scholarship or designated fund if so requested by the donor. In addition to the above, if, in the due diligence process, an organization is found to require expenditure responsibility based on the fund type or the organization's tax exempt status, CFCG staff determines if the project has a charitable mission. If so, and if the Board of Directors approves making the grant, staff develops a grant agreement to present to the recipient organization.
