three(3) times a year - fall, spring and the Annual Meeting in June - at locations and times set by the Georgia Elks Association. Meetings are conducted separately to conduct business, elect officers and appoint committees and meet jointly for special guests and programs.

Funds are raised to support Elks Aidmore, Inc. through fund raising projects and donations from local auxiliaries. The funds are given to Elks Aidmore, Inc. at the Spring meeting and any overage from the budget is presented at the Fall meeting, after the annual audit.

Elks Aidmore, Inc. has a residential program in Conyers, GA for young women (12-21) who have been removed from their homes, to provide safe housing, education, training, therapy and life skills. There is also a transitional living program for older youth, community based alternatives for youth and foster care. There are foster care offices located in Dalton, GA, Savannah, GA and Valdosta, GA.

Georgia Elks Aidmore Auxilliary has three positions on the Board of Trustees, three positions on the Executive Committee and numerous volunteers on campus for various activities. Every function of the Auxilliary is documented in a Handbook. The Georgia Elks Aidmore Auxilliary Officers, Committees and local auxiliaries are identified in the Directory of the Georgia Elks Association published annually for all members identifying support for Elks Aidmore, Inc.
