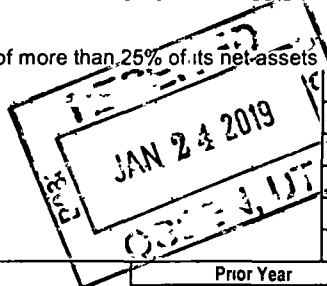

HIGH SCHOOL JUNIORS AND SENIORS WERE SELECTED TO SPEND A WEEK IN TALLAHASSEE, FL LEARNING LEADERSHIP SKILLS, PARTICIPATING IN SOCIAL ACTIVITIES AND NETWORKING WITH EACH OTHER. INCOME AND EXPENSES FOR THE FORUM OCCUR OVER TWO FISCAL YEARS, WITH MOST REVENUE GENERATED IN THE PRIOR FISCAL YEAR, AND MOST EXPENSES INCURRED DURING THE YEAR OF THE FORUM.
