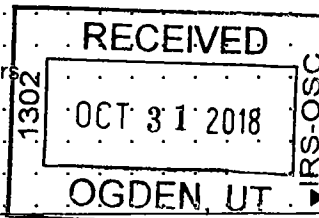

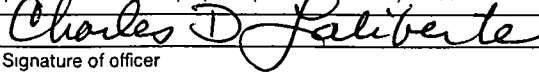

Part 1 Line 16: This year the board is recording more expenses that had previously been paid out-of-pocket and not previously included in our accountability. In 2019 the board member's annual trip to Uganda, which is essential to our mission, will be paid from ChildrenUP funds. As we grow, we are recording more and more of our expenses in order to show the true cost of doing business. This line includes banking fees, government licensing fees, credit card fees, and internet website and Dropbox subscriptions.

Part III Line 28: EXPLANATION OF THE GULU EDUCATION PROJECT

At present, 25 secondary school students and 4 certificate students receive tuition and fees, room and board, supplies and transportation from Children UP. Our advanced students, two in diploma programs and one in a degree program participate in cost-sharing support. ChildrenUP provides students with the very important service of mentoring. In-school mentors attend to the student needs and any issues arising with the particular school. Our ChildrenUP staff visit all our schools to monitor and coordinate with the in-school mentors, to oversee and address student concerns and to assure that tuition and all expenses have been paid. The staff and mentors advocate for the students and foster communication with parents and guardians. The board requires funds for six years of schooling before inviting a new beneficiary. This year we added ten new students. Next year we will add another ten students to Senior 1 classes. We strive to invite an equal number of young women and young men into the program. Students are eligible for renewed support by achieving strong grade results in division 1 or 2, maintaining good discipline in their schools and communicating actively with mentors and staff. As part of the project, our students write letters to share their educational experiences and illustrate aspects of their Acholi culture with sponsors and others in the USA. Among our first nine "pioneer" students, five are productive members of their communities working in their field of study. Two students just completed their diploma programs. One is in the midst of a degree program in medicine on government scholarship. Our new branch office in Gulu has part-time staff working to meet our ever-growing needs.
