The Organization leases a facility serving a maximum of six adolescents with substance
abuse disorders and co-occurring mental health conditions. The facility is licensed
by Washoe County as a specialized foster care home and is staffed 24 hours a day.
Adolescents admitted to the residential Quest House stay for an average of four months,
during which time they attend the Organization's outpatient office every weekday
morning to participate in group, individual and/or family counseling and return to the
House for an afternoon of school work and activities. The facility is a site for a local
charter high school which utilizes the A+ curriculum wherein credits are
transferable to any school in the district. The residents also participate in
