Since 1998 DKC has provided thousands of students the opportunity to learn and grow by participating in academic debate. DEBATE-Kansas City has served 1128 active participants this season. This represents the largest single season active participant number ever in league history. DKC held 15 tournaments, with 2,490 total entries for a grand total of over 9,000 rounds of debate and student congress this season. DKC also held three student workshops, four coach professional development trainings, a summer camp for students and coaches, as well as hosted three public debates.
