We provide services to low income residents of the Irish Channel, St. Thomas and Lower Garden District neighborhoods. These services (all at no charge) include: adult education, emergency financial assistance, food pantry, job search and career development, after-school youth recreation, free access to computers and the internet, prison visitation, and a free coffee house for homeless people. We also work with other organizations on social justice issues like housing, prison reform, and economic justice.

Adult Education/Career Development - assist students in developing their basic academic skills, in preparing for the state's high school equivalency diploma, in choosing and applying for post-secondary education/training, and finding employment. Over 260 students participated in the program. Over 60% of the students who participated for at least 40 hours improved their academic skills at least on NRS educational level.

4b (Code:) (Expenses \$ 96,936 including grants of \$ 81,824) (Revenue \$)
The emergency assistance program provides rent, utility, food and other assistance to neighbors in crisis (facing eviction or loss of utilities, not having enough food, burying the dead, ill and in need of medication, etc.). The program also provides advice and referrals assistance in filling out computer-based applications for benefits and employment, and advocacy in disputes with landlords, etc. During the fiscal year, the program assisted 78 households with rent, 298 households with utility bills, 36 students with testing fees, 10 families with funeral costs, 6 households with security deposits, and 7 individuals with miscellaneous issues.

After-school Youth Recreation - The program provides supervised recreational activities for neighborhood children on weekdays from 3 PM to 6:30 PM. Children are also provided with a snack. On average, 30 children participate daily.

people also bring a lot of used clothing to Hope House. We simply put whatever is brought out on a couple of tables on our porch. Interested people take what they want. We don't count it or weigh it or put a value on it. We simply let people take what they find useful.

All payments for assistance are made by check or on-line to the person or company providing the service to the person we are assisting. For example, for rent assistance checks are written to landlords, not to tenants. Payment is based on amount owed as verified by a 5 day notice to vacate and confirmed with a call to the landlord/owner. It works in similar ways for all the other payments made (except food). Regarding our food pantry, we follow the guidelines of the local Second Harvest Foodbank, of which Hope House is a partner.

Part III, 4 d. Here are the other smaller programs/activities we have Common Grounds Coffee House (for people who are homeless. takes place on Mondays, Wednesdays, and Fridays, 9 - 11 AM. Serves coffee and pantries to all who visit. Averages about 20 people a day. Cost: \$5,942. Much of the coffee and pastry donated by a wide range of people

Prison Visitation involves one staff member who is a volunteer chaplain at the local jail. She visits the women forced to live there while awaiting trial. There are no expenses for this activity

Education for Justice Workshops - workshops aimed at educating people about issues of poverty and justice. We did only three such workshops this year, involving about 40 college students. Again, there was no cost for this program.

Affordable Rental Program - We have 6 apartments that we rent out/lend out. The rents are kept low. The apartments are always full. Rents totaled \$22,065. Expenses totaled \$18,874. During parts of the year 2 apartments were provided to homeless people at no charge until they were able to get income.
