The organization operates four facilities in the Oklahoma City metro area Adult Day Care Program 358 days of service averaging 145 individuals per day. DLC provided 35,000 noon meals, 65,000 snacks, 95,000 nursing contacts, 30,000 transportation contacts and over a million activity contacts. 80% of clients reported satisfaction with the program. 15% did not respond to satisfaction survey. There were zero with negative responses. Over the last seven years the DLC has provided over \$1,523,499 worth of free services to individuals needing the services that the DLC provides.
