personal consultation, application assistance and legal representation for our clients in matters of petition for alien relatives,
adjustment of status, consular processes, naturalization, work permits, visa renewal, DACA and other related areas of family-based
immigration. Additionally, Catholic Charities handles humanitarian relief in cases involving refugee and asylee benefits and
Temporary Protected Status. We offer services for victims of domestic violence, certain other crimes, and for victims of human
trafficking. We employ a highly trained and professional staff that includes representatives accredited by the Department of Justice
as well as immigration attorneys.

In FY2018, we served 1,576 clients and 96% of applications were approved by the federal government

In May 2015, Catholic Charities assumed operation of the Diocese of Austin's Family Counseling Program. Licensed professionals
provide confidential, high-quality, affordable mental health services to individuals and families. Services are offered on a sliding
fee scale, can be accessed in person or virtually, and are available in multiple languages.

In FY2018, 605 clients received 3,557 counseling sessions, and 76% of clients reported a 20% reduction in symptoms after three
months of counseling.

Disaster Response was formerly included in Financial Stability but became a stand-alone program in FY2017. The program responds in the immediate aftermath of a disaster with emergency assistance and during the recovery phase with long-term case management. A full-time coordinator helps disaster survivors on their journey to a new normal in partnership with long-term recovery teams and provides preparedness training.

In FY2018, we served 3,809 individuals impacted by Hurricane Harvey and the 2015 Memorial Day floods

Gabriel Project Life Center Expenses \$386,860 including grants of \$34,801 Revenues \$233,053

Gabriel Project Life Center provides case management services to parents in order to give their children a healthy start at life. Services include free pregnancy testing, group classes, emotional and material support and case management services until the child's 3rd birthday. Over 400 classes are offered throughout the year using the "Earn While You Learn" model – a curriculum used around the country that covers all trimesters of pregnancy, birth, early parenting skills, newborn care, breastfeeding, and bonding. As families graduate through the program, they go on to learn other life affirming skills such as financial management, safety, and positive parenting techniques for child development.

In FY2018, we served 2,846 clients, and 100% reported increased positive attitudes toward parenting

St. Michael's Veteran Services Expenses \$357,899 including grants of \$131,919 Revenues \$284,489 Part III, line 2

St. Michael's Veteran Services provides case management, financial assistance, and referrals for veterans, active military and their families. In the program's first year of operation (FY2018), 230 veterans and family members were served and 75% reported an improved outlook on life.

Parish Relations builds partnerships that integrate the missions of Catholic Charities and parishes within the Diocese of Austin.
