Presidential salaries of comparable not-for-profit schools are analyzed in determining the President's compensation. The process is documented in board and committee meeting minutes and human resources forms. Compensation for other officers is established using comparability data from various sources and is approved by the President. Deliberations occur during the annual performance review process. Final decisions are documented with the human resources office, and employee performance reviews are filed with the President's office.
