Pt VI, Line 5	At one particular military installation, AWCF interfaced with a contract employee of the installation whose job it was to identify and evaluate certain financial needs of the soldiers and request funds on their behalf which are classified as "grants" on the return. That contractor was issued \$65,502 in grants, intended for servicemen and servicewomen. The contract employee is currently under investigation for mishandling funds from the Foundation and other similar organizations. However, at this time, there is not enough evidence to substantiate that all of these funds were used for the intended purpose. Additionally, Management of the Foundation believes that if the wrong doing is found, it is unlikely any of these funds will be recovered.
