Salaries and commissions for our teaching pros. In 2017 KVTA employed one Head Tennis Professional and two part-time Tennis Professionals. These Tennis Professionals provided Youth Programs for over 100 youth, including Red Ball and Orange Ball instruction for youth under 10. They provided Middle and High School programs for approximately 50 players. For Adults, our tennis professionals provided Adult Beginner, Adult Advanced, Triples, Cardio Tennis, and drill clinics. These adult programs served over 50 players. In addition, each Tennis Professional gave private, semi-private, and group lessons to at least 70 (approximate) different players, many of whom also participated in the aforementioned clinics.

Our Head pro organized a weekly Friday Night Mixer in which 16-20 players participated each week.

KVTA has about 70 Members and many non-members who rent the tennis courts and the pickleball courts. Though there are no direct expenses for court rentals, obviously lights and heat need to be provided. This is one of our largest revenue streams.

KVTA also was home to two USTA League Teams, each of which hosted an inter-club match.

Our pickleball program was host to three pickleball tournaments, which had 80-200 participants.
