June of 2017 there was a team of 6 Americans including one eye doctor that held an eye clinic in Dessalines, Haiti. Volunteers assisted in the exams as well as taking measurements for those needed eye glasses. Many were treated for glaucoma and other diseases of the eyes.

Recommendations were given from the eye doctor as to those that needed surgery or any other medical needs pertaining to their vision.

This saves the surgeon much needed time when they arrive to do the surgeries. 225 patients were examined and treated.

From September 2017 through May 2018 support was given to Institution Mixte Peavy School which is associated with the Ebenezer Glen orphanage. We provided book bags, food, water, teaching supplies and general support for the school which reaches around 150 children.
