The organization also provides educational programming that inspires artistic expression and understanding. Approximately 21,000 members of the public were exposed to art through visits to the museum or through other outreach programs by providing a wide-ranging and exciting schedule of exhibits and educational opportunities. Paris Gibson Square insures that art is for everyone regardless of age, ability or financial circumstances.
