



Awareness Events/Community Information Nights: The organization hosted EMBRACE Day, a resource fair with over thirty (30) organizations in the Greater Kansas City area that provide services for all children including those with exceptionalities. EMBRACE sponsored Community Information Nights with speakers on topics of interest in support of our mission and to provide awareness and general guidance to parents and teachers. Childcare and activities were provided by teachers, therapists, and other volunteers.
