OFCV led the development and implementation of the Coachella Valley Regional Plan for College and Career Success, a cross sector plan to improve opportunities for students across their educational journey from K-12 into college and jobs. As a result of the Regional Plan, OFCV and partners have achieved significant outcomes:
- Increased career academies across all three school districts - increasing from 5 career academies and pathways serving in 600 high school students in 2006 to 47 academies and pathways serving 6,500 students in 2017.
- Increased valley-wide FAFSA (Free Application for Federal Student Aid) completion from 48% in 2011 to 70% in 2018: with a potential of \$3.4 million in additional financial aid available to our students.
