Form 990, Part III, Line 4a:

The National Institute for Criminal Justice Reform made tremendous progress in FY 17-18 toward its mission to transform the juvenile and criminal justice systems and drastically reduce gun violence. NICJR strives to reduce incarceration, improve the outcomes of system-involved youth and adults, reduce violence, and increase the capacity of organizations that serve currently and formerly incarcerated individuals. The following are brief updates on the areas of enormous progress made by NICJR in FY 2017-2018.

NOAB In Oakland, the NICJR further developed its Neighborhood Opportunity and Accountability Board (NOAB) model, an initiative that ultimately seeks to transform the youth justice system as we know it by empowering youth and community members to determine how youth who commit delinquent acts can be engaged in positive developmental strategies as opposed to relying on punitive, deficit-based practices. The NOAB also seeks to reinvest the significant resources spent on a dysfunctional system in to communities, families, and youth. Initially, the NOAB will serve as a local program that will divert youth from the juvenile justice system and, instead, utilize neighborhood councils to address delinquent behavior. The NOAB Steering Committee, which includes representation from community leaders, youth development professionals, restorative justice professionals, the Oakland Police Department, Alameda County Juvenile Probation, the Alameda County District Attorneys Office, Restorative Justice for Oakland Youth, the Carl B. Metoyer Center for Family Counseling, and Youth Uprising, met monthly during 2018 to develop the pilot program set to launch in 2019. The NOAB has built tremendous support from community and system stakeholders and is in the process of raising additional funds for program implementation. Oakland's Police Chief Anne Kirkpatrick expressed support for the NOAB stating "when implemented effectively, NOAB can improve youth outcomes, develop communities, and increase public safety. The Oakland Police Department looks forward to working with NOAB and highly recommends and encourages funders to support this strategy."

Youth Justice Advocacy Guide NICJR published a guide for youth justice reform advocates to help understand the complicated layers and silos of California's juvenile justice system. NICJR also led a webinar to present the details of the guide where more than 50 advocates from 30 organizations across the state participated. The Guide was also provided to advocacy organizations in the Sierra Health Foundation's Positive Youth Justice Initiative. The City and County of San Francisco NICJR began working with the City and County of San Francisco (SF) Department of Children, Youth, and their Families (DCYF) to deliver programmatic technical assistance and capacity building to justice agencies and community-based organizations. The on-going work will include NICJR conducting an assessment of the San Francisco juvenile justice system and determining areas where youth can safely, responsibly, and effectively be diverted from formal system processing to community-based alternatives. In addition, NICJR will assess programs, initiatives, and policies throughout the country that reduce youth involvement in the formal system and increase community engagement. NICJR will then facilitate a series of discussions with key stakeholders in SF to get input and feedback. Using data and information from the SF assessment, the national landscape analysis, and input from key local stakeholders, NICJR will then develop statewide and national recommendations regarding methods to significantly reduce the use of juvenile detention and probation and out of area private placements, and increase the use and engagement of community-based service providers. If implemented, these strategies can lead to the outright elimination of state Departments of Juvenile Justice.

Massachusetts In 2018 the NICJR provided a full day training on Positive Youth Development (PYD) to Massachusetts juvenile justice and child welfare agency staff as well as local community service providers. Nearly 100 officials from child serving agencies participated in the full day training at Boston University which focused on how PYD can be implemented in the juvenile justice system. The training included the provision of specific implementation tools that participants designed to ensure the ultimate goal of reducing the number of youth in the system and improving the outcomes of the youth who remain.

Rutherford County, Tennessee NICJR conducted a four-day training for all probation officers in a newly created Probation Department in Rutherford County. The county had been sued for using a privately run probation department which was imposing excessive fines and fees and violating clients' probation based on these fees, resulting in high incarceration rates. Subsequent to being sued, the county ended the private probation contract, created a government agency to provide probation services, and asked NICJR to train all of its probation officers in positive client development, racial bias, and procedural justice.

Los Angeles County Probation NICJR played a major role on the team of advisors to the Los Angeles County Board of Supervisors in the development of a comprehensive assessment of the county's Probation Department. The year-long study culminated in the publishing of a detailed report on how to thoroughly reform the largest probation department in the country. NICJR continues to provide technical assistance to the county through the Probation Reform Implementation Team, a commission established by the Board of Supervisors to ensure that the report is implemented. Oakland NICJR provides technical assistance to the City of Oakland's Gun Violence Reduction Strategy, also known as Ceasefire. The initiative has been credited, and verified through a rigorous external academic evaluation, with being the primary cause of a 50% reduction in injury shootings and homicides in the City of Oakland over the past five years. Stockton, CA In Stockton, NICJR has worked with the Office of Violence Prevention (OVP) to design and implement its gun violence reduction strategy. NICJR wrote the operational protocols manual for the Stockton OVP and trained all staff in the new protocols in March 2018.

Atlanta, Georgia NICJR and its partner Advance Peace conducted a full day training for over 100 violence reduction practitioners from 15 different cities across the country at Ebenezer Baptist Church in Atlanta in March 2018. NICJR trained participants on its violence reduction models, sharing keys to successful implementation and sustainability. This training led to tremendous interest from jurisdictions across the country interested in partnering with the Alliance to implement its violence reduction model in their communities.

Orlando, Florida NICJR and its partner Advance Peace conducted several trainings on its violence reduction model in Orlando including training the Orlando Police Department, Orange County Sheriff's Department, and officials from the state's Probation Department, as well as community leaders and street outreach workers.

Cost of Violence Studies NICJR conducted and published studies on the cumulative costs of homicide and injury shootings for several cities across the country. These studies are primarily used by community advocates to try to build political will to move away from traditional and ineffective violence reduction strategies and to pilot, if not adopt, the Alliance's violence reduction model or at least key components of that model. At the time of submission of this grant report, the Alliance has published Cost of Violence studies for Oakland, CA, Orlando, FL, Miami Gardens, FL, Indianapolis, IN, Birmingham, AL, and Mobile, AL. Form 990, Part III, Line 4b:

Young Professionals of Color FellowshipNICJR launched the Young Professionals of Color (YPOC) Fellowship in June 2018. The Young Professionals of Color Fellowship is a leadership development opportunity for emerging leaders advancing the well-being of communities of color through various avenues of social justice. Through the fellowship, the Alliance has worked to develop extraordinary leadership and cultivate expertise among young professionals of color in the fields of criminal justice reform, urban gun violence reduction, community organizing, and social justice generally. YPOC Fellows participate in a series of learning engagements that provide them the opportunity to network with and learn from a variety of leaders in the fields of violence prevention, criminal justice reform, community organizing, education, philanthropy, and more. The inaugural cohort of the YPOC Fellowship features seven young professionals who were selected from a pool of candidates across the state and hold various positions in the fields of public health, violence reduction, criminal justice reform, education, youth development, community organizing, and public safety. Fellowship convenings focus on building leadership capacity and feature professional development and training opportunities covering a cross section of topics including fund development, organizational management, fiscal management, public speaking, networking, strategic planning, policy development, branding, communications, and more. Fellowship convenings also feature guest lecturers with extensive expertise and a demonstrated track record of innovative leadership in their respective fields including Angela Glover-Blackwell, Chet Hewitt, Arnold Perkins, Lateefah Simon, Michael McBride, DeVone Boggan, David Muhammad, Shawn Ginwright, Arnold Chandler, Jacqueline Martinez Garcel and several more to come. The convenings provide an opportunity for fellows to build personal relationships with these esteemed leaders in intimate settings, which is already resulting in long-term mentorship opportunities for the fellows.
