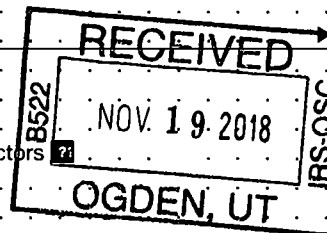

What is the organization's primary exempt purpose:

Asali's mission is to improve childhood quality of life worldwide through education, arts, and health initiatives. Asali collaborates with partner organizations to develop programs focused on improving the lives of children around the world.

Asali partners with Simba's Footprints, an organization in Tanzania that runs after-school programming and events at its community center in Moshi. Through mentorship, financial support, and program development, Asali supports three major programs at Simba's Footprints. All projects are a collaboration between Asali and Simba's.

English Initiative

One of Asali's major goals is the English language development of our children. English is critical for Tanzanian students' education, as after Standard 7 (ages 12-14), the entire education system switches from Swahili to English. Students are required to pass the National Examination in order to access education beyond Standard 7. This test contains a difficult English language section focused on vocabulary, grammar, and conversational English. Many students are unable to complete their education because they are unable to pass the exam. In response to this, Asali's flagship program is focused on increasing access to high-quality English education. Our current English initiative is two-fold, providing an English Club during school hours and teacher trainings after school.

The English Club is a program that sends Asali English teachers into the local primary school in Majengo, Tanzania. This program targets students who are highly motivated, but struggling to learn in the dictation-style classroom common to Tanzania. The English Club currently serves more than 45 children, ages 8 to 14, during a free block in their school day. Asali's teachers use interactive and engaging teaching methods in order to improve the students' fluency and confidence in English. Each week, new vocabulary is introduced and old vocabulary is

reinforced. The students have access to vocabulary sheets with visuals to help them practice at home. Asali's investment in the English Club this year totalled \$2,603.

Another important piece of the English Initiative is teacher training for educators at the Langoni School. Training the teachers to use more modern methods enriches their teaching practices and their own English proficiency. This mentorship-style program encourages educators to be more impactful with the children in their classes and their communities. This ripple effect will allow Asali to reach many more students through different teachers and schools than would be possible as an isolated organization.

Asali Library

In response to the need for English resources, Asali built and filled a library at Simba's Footprints Community Center. Picture books, textbooks, and educational resources were donated by libraries and schools in the United States and delivered by Asali's on-site Director, Margot Hinchey. Picture books, in particular, are difficult to find in Tanzania, but an essential component of early childhood education. Simba's teachers and students from the surrounding community have access to the Asali library. Teachers have daily access, while students have scheduled "Open Library" twice a week which consists of free reading time, lessons on respecting books, and teacher assistance. The cost of building and filling the Asali library with donated books was \$3427. Access to literature is a great predictor of academic success. Asali aims to give children in Moshi every advantage possible as they pursue their academic goals in the rigorous Tanzanian education system.

Music Program

In response to an outpouring of requests from Simba's Footprints students and community members, Asali built its music studio in May of 2018. Asali filled the refurbished room with donated guitars, keyboards, and a variety of percussion instruments. Asali also provided a public address (P A) system and microphones, a contribution totaling \$446. Moving into our next fiscal year, Asali plans to hire local musicians Peter (Keyboard and Bass player) and Dialo (Guitar, Drums and Saxophone player). Peter and Dialo offer lessons and studio time three days a week to Simba's Footprints students, teachers and community members.
