UWSW launched the program Dolly Partons Imagination Library in Southwest Wyoming in 2010. This program mails a free, age appropriate book every month to children from birth to age 5 that live in Lincoln, Sweetwater and Uinta counties. Currently, 2,461 children are enrolled with 3,790 having graduated from the program. This is part of our education initiative to help children be kindergarten ready. The cost is about \$35 per child per year. The Dollywood Foundation pays for the books. Our job is to raise the funds for the shipping of the books, promote the program and to maintain the database by registering children and approving online registrations.

Form 990, Part III, Line 4c:

UWSW manages Community Diaper Banks. Diaper need is the lack of a sufficient supply of diapers to keep an infant or toddler clean, dry and healthy. There is not a government program that assists with diaper need. Over 330 families used the Community Diaper Bank of Sweetwater in 2017. Through a partnership with the Foodbank of Sweetwater County, any family in need can receive one package of diapers per child during Food Bank distribution days in both Green River and Rock Springs. In 2017, 60,031 diapers were distributed. The Community Diaper Bank of Sweetwater County receives cash donations from grants, businesses and individuals. Community diaper drives are also held to collect diapers for distribution. In May 2018, UWSW expanded into Uinta County with a partnership with Uinta BOCES 1. Diapers are distributed from the BOCES building once a month. In August 2018, a partnership was formed with Lyman Town Hall and diapers are distributed there once a month.
