THE PREGNANT AND PARENTING YOUTH INITIATIVE PROVIDES SAFETY, STABILITY AND WELLNESS FOR YOUNG FAMILIES, INCLUDING PREGNANT AND PARENTING TEENS' CASE COORDINATORS WORK TO CONNECT FAMILIES WITH PRENATAL AND POSTNATAL CARE, CHILDCARE RESOURCES, PARENTING CLASSES AND WORKSHOPS, AND PREGNANCY PREVENTION. 42 YOUTH AND CHILDREN WERE SERVED AND 454 INTERVENTIONS PROVIDED, INCLUDING CLOTHING, BABY FORMULA, DIAPERS, MEDICAL REFERRALS, PARENT EDUCATION CLASSES, AND REPRODUCTIVE HEALTH INSTRUCTION.
