The VFW Department of Arizona maintains a robust network of both employees and volunteers whose main objective is helping veterans navigate the intricacies of the Department of Veterans Affairs. This includes applying for benefits, enrolling in health care and solving various problems that can and do arise when dealing with the VA. This is in keeping with the VFW's slogan of "Veterans Helping Veterans." The outright expenditures related to this important function approaches \$175,000 yearly, not counting the untold number of hours by our VA volunteer services members.

The VFW Department of Arizona, with the help of its state-wide affiliates, have donated in excess of \$68,000 supporting the VFW programs. National Home for Children and the VFW Veterans and Military Service which include Operation Uplink, Unmet Needs, and Military Assistance Program are priority programs. The VFW's Veterans & Military Support programs are the driving force behind our troop and family support efforts. In addition, the Department of Arizona has a Veterans Homeless Fund, and cemetery squads dedicated to honoring those who served as they are laid to rest.

The VFW Department of Arizona also sponsors many youth activities such as Voice of Democracy oratory contest for high school students, Patriot's Pen essay contest for middle school children, scouting program, and recognition for our state's teachers. Other programs include recognition of first responders, patriot art, and upwards of 170,000 hours in our various communities helping those less fortunate whether they be veterans or not.

Part VI, A1 : The Governing Body meets 3 times a year between annual conventions. The purpose of these meetings is largely to report on activities conducted in their respective Districts since the last meeting and to inform the body of upcoming activities. Expenditures are almost exclusively governed by the budget which is formally adopted at the first meeting. If an emergency expenditure arises that is not covered by the budget it is generally minor in nature and pertains to some type of assistance to the veteran community.

Part VI, A6-7: The VFW is a membership organization and as of June 30, 2018 has 25,00+ members. These members elect the governing body annually, either at their respective District meetings or at the annual convention through their respective delegates.

All members are entitled to formulate policy and procedure to be voted on by all delegates attending the annual convention as long as it does not violate law or conflict with the Constitution and By-laws of the National, State, and local organizations.

Part VI, B11: The 990 is reviewed by the Internal Audit Committee and discussed initially with the line officers of the organization. The governing body is alerted to its completion and is given an opportunity to review the document prior to submission.

Part VI, B12: Members of the governing body are reminded at every meeting of the existence of the organization's Conflict of Interest policy. The Internal Audit Committee scrutinizes every transaction made by the organization and is acutely aware of the policy.

Dues Reserves (\$80,467) are restricted as to time and are released to unrestricted net assets as of July 1st of every year.
