After the finance officers injury, the remaining governing officers worked through access issues to the financial records and ultimately, hired an outside bookkeeping service to assist. Together they have reconstructed the books for the entire fiscal year using bank transactional data, contacting vendors, etc. Every effort was made to file the return as timely as possible once a complete and accurate set of books was available. With this new bookkeeping firm in place, it is anticipated that returns will be timely filed from this point forward. As evidence of this commitment, the fye 06/30/2019 return, which was properly extended, will be filed simultaneous to this filing months before the extended deadline. We again respectfully request that penalties for this return be waived at this time.
