The mission of the Friends of Utah County Children's Justice Center is to foster and support the Utah County Children's Justice Center Program (CJC) through raising private and public funds to provide services in behalf of abused children and their families. The CJC seeks to reduce trauma to child abuse victims by facilitating the criminal justice response with a multidisciplinary team, and to provide therapy access for victims/families in a safe, child-friendly facility known as the Utah County Children's Justice Center

Facilitated access to outpatient mental health therapy in behalf of more than 350 child victims and directly impacted, non-offending family members. These grants were paid directly to community mental health treatment providers for LMI families that would otherwise not receive critical needed therapy for the child abuse trauma that they have suffered. Additionally, this amount was significantly leveraged to serve as many children and families as possible through the partial donation by these therapists of their services at 50% of the normal fee for services

**4b** (Code: ) (Expenses \$ 57500.87 including grants of \$ 39876.93) (Revenue \$ )  
Grants of \$34,376.93 were paid to Utah County Government in behalf of the Utah County Children's Justice Center Program for professional services, training and supplies for the use of the CJC Program in behalf of child abuse victims. Additionally, \$17,623.94 was paid to upgrade professional interview recording equipment for the child-friendly facility. In an effort to better serve the children and families from our adjacent county (Juab) who had been utilizing this CJC, we rented a small facility in Juab County to provide services more convenient for these families to access, which was paid by a grant that our organization received for this purpose and paid to CWCIC, a non-profit organization, in behalf of the developing Juab County CJC, to share space with them for this purpose. The CJC facility is provided for full use of the Utah County Government's Children's Justice Center Program, by lease from our CJC Friends organization, as part our charitable mission. (a \$1.00 lease fee is paid by Utah County Government to validate the lease contract so that full liability coverage for the CJC facility and staff (Utah County Employees) is provided under Utah County Government. The depreciation expense for this facility is \$20,960.00 per year

A significant part of the charitable mission of the Friends of Utah County Children's Justice Center is providing and maintaining a child-friendly facility, known as the Utah County Children's Justice Center, for the use of children and non offending family members when there are allegations of abuse, in order to interact with professional members of the multidisciplinary response team and to receive needed services, such as therapy. Part II, line 10 indicates a payment of \$1 from Utah County Government in order to maintain the lease contract of our organization with Utah County Government, so that the Utah County CJC Program is provided full use of this facility for the above purpose and the County provides insurance and liability coverage for the facility.

The small decrease in "public support percentage" is entirely due to the increased amount donated by a few foundations and businesses for multiple years because of their loyal support and investment in our charitable purpose. While this negatively impacts the calculation of public support used for this line, it actually reflects very highly on the integrity of this organization and the importance of our charitable mission. At the same time we also have experienced increased numbers of small donations from multiple individuals and businesses.

Part II. The Friends of Utah County Children's Justice Center provides the community a donated child-friendly facility for the Utah County Children's Justice Program to serve alleged child abuse victims of child abuse and child witnesses of violent crime. It is leased to Utah County Government for \$1 per year (essentially without charge for this 10,000 square foot facility). The actual value of this space is estimated to be more than \$60,000 per year if rented. Cash grants to Utah County Government for the Utah County Children's Justice Center Program were made to cover professional training, supplies, essential salary costs, and other program service costs, including temporary rental of CJC Program facility in Juab to better serve rural child victims of abuse.

Part III. Grants for professional therapy were made in behalf of needy individual child abuse victims to allow access to critically needed age-appropriate therapy services provided by a number of licensed mental health treatment providers in our community. Payment was made directly to the therapists (@50% of invoiced costs) to pay for these services. Therapists had agreed to direct bill these services to our organization when the individual served had been previously screened for need and did not have adequate means to be able to access appropriate therapy for child abuse trauma.

Form 990, Part III: The purpose of the Friends of Utah County Children's Justice Center is to foster and support the Utah County Children's Justice Center Program (CJC) through raising private and public funds in behalf of child abuse victims in our community. The purpose of the CJC Program is to reduce trauma for victims of child abuse and child witnesses of violent crimes, particularly sexual and physical abuse, by coordinating and facilitating the criminal justice system and child protective system responses to these victims through a multidisciplinary team intervention in a safe, non-threatening, child-friendly facility known as the Utah County Children's Justice Center. This home-like facility and much needed major addition to this facility are held in trust for the community by the Friends of Utah County Children's Justice Center, a non-profit, charitable organization. Additionally, we provide funding to the CJC Program, which functions under Utah County Government, as needed. This support can include training for MDT professionals and medical services. This year the Friends organization has also provided funding to rent a facility in Juab County to provide the CJC services for children / families within their community, rather than traveling to us. We hope that we can encourage the local community to support and provide the CJC program within their own community within two years.

We also provide significant funding each year for age-appropriate child abuse victim treatment for abused children and their impacted non-offending family member to promote healing and restoration to productive lives. Public awareness and education are provided to involve the community in being part of the solution to child abuse issues for the children of our community, as a part of our charitable purpose.

While we continue to support the healing programs of the Utah County Children's Justice Center, we also provide funding to periodically refurbish, maintain, and refurnish the CJC facility, as needed. This may include replacing and upgrading essential equipment, as part of our charitable purpose. We also receive significant non-cash contributions that provide much needed clothing, toys, books, etc. for very needy child clients and families during this time of crisis in their lives. We strive to promote hope and healing in the young lives of these children. The Friends of Utah County Children's Justice Center organization is a community-based dedicated volunteer organization.
