Food Bank: North Helpline Food Bank operates two food bank sites. The food bank in  
Lake City distributes food every Wednesday, Thursday, and Saturday. The food bank in  
Bitter Lake distributes food every Saturday. In the six months ended June 30, 2018  
clients visited the food banks 21,394 times and North Helpline distributed food  
equivalent to over 599,842 meals.

Emergency Services: Emergency Services (ES) provides financial assistance to prevent  
eviction and utility shut offs. Clients can also access hygiene supplies, sanitary  
supplies, diapers, baby food, detergent and referrals to other agencies. The  
Community Connector assists clients enrolling in benefits and connecting to  
resources. There were approximately 10,000 household visits during the first half of  
2018. Emergency Services operates four days per week and the Community Connector is  
on site five days per week.
