LOCAL CAPACITY BUILDING IAF NW continued its core work of building the capacity of local leaders & organizers to improve the welfare of their communities. That work included conducting advanced 6-Day Leadership Institutes for community leaders in the US, Canada, New Zealand & Australia, organizing 3 multi-day seminars/training sessions for the professional organizers, & providing weekly phone consultation & on-site mentoring support to organizers & key leaders from the 12 affiliated organizations located in northwestern US, southwestern Canada, Australia & New Zealand. Highlights of the work by & with the affiliates include: Engaging 150 experienced leaders in 6 IAF Six Day Leadership Institutes that provided comprehensive training in community organizing principles, & built in-depth relationships across diverse constituencies. Those trainings were held in Portland, Sydney & Auckland. Supporting its affiliated organizations in successful campaigns related to expanding affordable housing, creating quality living wage jobs, & increasing access to public transit, among others.

REGIONAL STRATEGIC INITIATIVES IAF NW continued to expand its efforts addressing health equity across the region. This year, the programs made significant contributions to addressing social determinants related to affordable housing (Portland) and physical education for at-risk students (Seattle).
