THE CONSORTIUM FOR RESEARCH ON RENEWABLE INDUSTRIAL MATERIAL'S (CORRIM) MISSION SEEKS TO ESTABLISH, SUPPORT AND MANAGE RESEARCH, AND EDUCATION PROGRAMS RELATED TO THE PRODUCTION, USE, AND FINAL DISPOSAL OF WOOD PRODUCTS INCLUDING FORESTRY OPERATIONS AND LIQUID AND SOLID CELLULOSIC FUELS. CORRIM'S RESEARCH FOCUSES ON THE ENVIRONMENTAL IMPACT THROUGH THE LIFE SPAN OF THESE PRODUCTS INCLUDING ENERGY USE, RESOURCE CONSUMPTIONS, AND ENVIRONMENTAL RELEASES IN THE FORM OF AIR AND WATER EMISSIONS, AND SOLID WASTE. CORRIM HAS PRODUCED GUIDELINES FOR EVALUATING ENVIRONMENTAL IMPACTS SPECIFIC TO FORESTRY OPERATION AND WOOD PRODUCTION TO BE USED IN CONJUNCTION WITH INTERNATIONAL STANDARDS FOR PERFORMING LIFE CYCLE ASSESSMENT. THE INTENT IS TO PROVIDE DATA FOR MANY USERS INCLUDING WOOD PRODUCT MA.
