AS A MISSION DRIVEN, NOT-FOR-PROFIT ORGANIZATION, MARY'S WOODS HAS THE PRIVILEGE OF ENHANCING THE LIVES OF BOTH THOSE WHO LIVE AND WORK ON THE CAMPUS AND THOSE RESIDING IN THE BROADER COMMUNITY. BEGINNING IN FISCAL YEAR 2012-2013, MARY'S WOODS BEGAN EXPANDING ITS FUNDRAISING SERVICES TO CONTINUE TO CARRY OUT THE ORGANIZATION'S MISSION. MARY'S WOODS ACCEPTS CHARITABLE CONTRIBUTIONS FOR FIVE FUNDS: (1) RESIDENT ASSISTANCE, (2) EMPLOYEE EDUCATION, (3) INNOVATION, (4) CAPITAL PROJECTS AND IMPROVEMENTS AND (5) GREATER NEED. OUTREACH INTO THE LOCAL COMMUNITY IS ALSO PART OF THE MARY'S WOODS COMMITMENT TO MISSION AND VALUES. UTILIZING THE INNOVATION FUND, MARY'S WOODS HAS ENTERED INTO A PARTNERSHIP WITH NORTHWEST HOUSING ALTERNATIVES (NHA) TO HELP THOSE SENIORS LIVING ON A FIXED INCOME WHO MAY ENCOUNTER BARRIERS TO GETTING THE CARE THEY NEED IN ORDER TO THRIVE IN THEIR ENVIRONMENT.
