OUR CLIENTS RANGE IN AGE FROM INFANT TO THE ELDERLY WITH DIVERSE PSYCHOLOGICAL, EMOTIONAL AND PHYSICAL ABILITIES/NEEDS. WE ALSO ROUTINELY SERVE WOMEN IN VARIOUS STAGES OF PREGNANCY. WE ARE THE ONLY DV ORGANIZATION WITH THE ABILITY TO WORK AT THIS CAPACITY IN SOUTHERN SOUTHEAST ALASKA. OUR PROGRAMS AND SERVICES INCLUDE BUT ARE NOT LIMITED TO: EMERGENCY 24/HOUR-7 DAYS/WEEK SHELTER PROVIDING 3 MEALS/DAY EMERGENCY TRANSPORTATION 24 HOUR CRISIS HOTLINE SEXUAL ASSAULT.
