LOCAL GROUP SUPPORT & CAPACITY BUILDING ROP builds movement power for human dignity and justice in small town and rural Oregon. We support a network of over 60 groups representing 31 of Oregon's 36 counties who organize their communities for social justice and democracy. Staff logged thousands of miles, meeting with groups in communities across the state to develop local organizing plans that build local group power, respond to hate activity and advance a more safe and welcoming community for all. Over 60 leaders joined us for 2 Rural People's Movement Assemblies on rapid response strategies, and more than 150 participants from 28 counties joined us in May 2018 for our Rural Caucus & Strategy Session, ROP's annual membership meeting, to share strategies from local organizing across the state, and to plan our work together as a network for the coming year.

SAFE & WELCOMING COMMUNITIES Rural Oregonians gathered in living rooms & community centers to respond to escalating vigilante violence & to build community so that every neighbor can live safely & with dignity. As immigrant & refugee communities experienced rising vigilante & state violence, we held Know Your Rights and Know Your Roles workshops in 12 communities to dive deep into how immigrants & allies can organize to defend their rights. ROP convened Rapid Response Strategy Sessions in 13 counties. Member groups surrounding NORCOR regional jail organized in support of immigrants & refugees inside on hunger strike demanding better conditions & an end to the jail's contract with Immigration & Customs Enforcement. From Union County to Coos County, ROP member groups led local Welcoming Community campaigns that promote inclusion & community over fear & division. For example, Cottage Grove Community United formed & responded when an "Aryan-style knife shop" operated by people with known ties to white power gangs & who were convicted for hate crimes in Lane County opened on Main Street.

INCLUSIVE DEMOCRACY As the militia, so-called "Patriot", and white nationalist groups promote divisive politics and recruit in our communities, ROP member groups work to promote a vision of safe and welcoming communities for all and inclusive democracy. ROP provides resources to groups to create a culture of safety and security and to incorporate organizing strategies that create space for all to be engaged in the decisions that impact their lives. For example, after countless more school shootings, hundreds of young people walked out, sat in, held vigil, and demonstrated in more than 25 rural Oregon schools to start conversations about what safety means. Enduring harassment, threats, and backlash from school administrators, student leaders bravely challenged their peers and their communities to include young people in the conversation on how to keep us all safe.

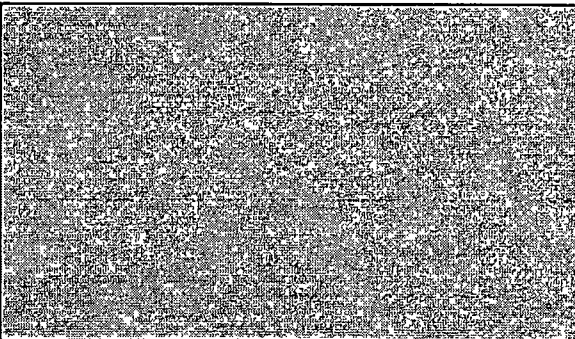
