Nature of Operations and Program Service Accomplishments:

New Hope Christian College (the College) is a private four year and graduate Christian College located in Eugene, Oregon. The College offers degrees in four areas of emphasis: theology, ministry leadership, creative arts and general education. The College also provides room and board facilities for students.

Significant Accomplishments:

This year the College increased the opportunities to enrich the experiences of our students academically and through extra-curricular activities.

We graduated 15 undergraduate students, which is typical, but we also had our first three graduate students achieving a Master of Arts in Christian Leadership. These students live in three different states and represent three different ethnicities. Talo Sataraka, hailing from Tokyo, Japan, where he pastors, delivered the commencement address.

Six of our female undergraduate students traveled to Israel over the summer for a time of reflection and repose with Dr. Lynn Jacobson.

Lynn is a faculty member of the College and founder of Beth Shalom Center to provide a bridge of understanding between the Jewish and Christian communities through dialogue and education.
