The Alumni E-Newsletter is sent throughout the year to alumni and friends to recognize and tell the stories of our alumni and students and as a way to let people know what is happening on campus with our chapters and clubs as well as with our programs and events. Chapter and Club Events. The Alumni Association's chapters and clubs also sponsor many events throughout the year to foster alumni ties and to bring attention to the alumni association program. Events include, but are not limited to golf tournaments, wine tasting, tailgates, conferences and award functions. Victor E Bulldog, Fresno State's live mascot, brings the spirit of the university to more than 200 appearances each year. Victor's appearances take place on campus, within the Fresno community and across the state of California. These events allow the University to engage with alumni, students, friends of the university and future Bulldogs.
