With a total enrollment of 1,263 students, representing 41 states and 11 countries, the College provides instruction, research, public service, and academic support to 774 undergraduate and 489 graduate students. On the undergraduate side, students of color represent 59% of the class, with 51% of graduate students being students of color. Thirty-nine percent of undergraduates are first generation students. The College provides financial aid, scholarships, and fellowships to both our undergraduate and graduate populations. Ninety-five percent of undergraduate students receive financial aid, with the average award being \$31,588. Of the total \$19.9M in aid awarded, \$9.3M was funded by Mills. Thirty-one percent of our students receive Cal Grants and 53% are eligible for Pell grants. The College's undergraduate Hispanic population is 25%, making us eligible to declare as an Hispanic-serving institution (HSI). The percentage of graduate students receiving financial aid was 85%, with Mills providing \$2.1M in scholarships and grants and \$360,855 in assistantships out of a total of \$9M of any financial aid awarded to graduate students.

The College provides auxiliary services, including student housing, food services, and other student services. We are expanding our articulation agreements with local colleges and universities to make transferring to Mills more transparent and easier for students. In addition, we are defining potential partnerships at the curricular and resource sharing levels with a county wide community college system and a major research institution nearby campus. These arrangements would allow for cross registration and potentially dual admission between institutions.

The net operating loss carryover will begin to expire June 30, 2025 for federal purposes and June 30, 2018 for California purposes. The College applied ASC 740-10-25, Accounting for Uncertainty in Income Taxes, to all tax positions for which the statute of limitations remained open and determined there were no material unrecognized tax benefits as of the year ended June 30, 2018 and the year ended June 30, 2017, nor are any changes anticipated in the twelve months following June 30, 2018.</p>
