Artists-in-Communities:

The Workshop's community-based residencies expand access to our sustained, sequential arts instruction in afterschool and community-based settings such as transitional housing facilities and juvenile hall schools. In these out-of-school time settings, our teaching artists create spaces where youth can experience joy and enthusiasm in learning and creative expression as they gain essential verbal, cognitive, and social skills. In 2017-2018, our teaching artists conducted 32 community-based residencies serving just over 600 youth in grades K-12.

Advocacy:

At Performing Arts Workshop, we believe that arts programs are an essential part of each child's education. We also believe that the arts make youth more innovative, creative, and better critical thinkers - which are vitally important skills for the 21st Century.

As a result, school districts, local and state government need to be held accountable for providing instruction in the arts. In 2008, Performing Arts Workshop launched its advocacy initiative to achieve this broader goal - beyond the bounds of what the Organization's direct service can provide.

The Workshop partners with public schools serving a majority of historically underrepresented youth: each year at least 80% of youth we serve are in low/lower-income families; 41% reporting are English learners, and 11% have Individualized Educational Plans. The youth in our classrooms bring a wealth of cultural and familial values and traditions that are spoken to, nurtured and shared through the Workshop's unique critical thinking-based method. In 2017-2018, the Workshop conducted 254 residencies for youth in preschools and K-12 public schools in San Francisco, Marin, and Alameda Counties. External evaluations of our school-based residencies conclude that students in yearlong residencies show increased proficiency in mathematics; reduced absenteeism; increased confidence especially among Special Education students; improved language comprehension and development, especially for English language learners; improved critical thinking skills; and improved collaboration skills.
