The center serves over 125 children, youth, 14-24. The Career Center works with 225 participants to provide them with basic skills, leadership development, and employment opportunities. The Environmental Training Center offers internship programs for 16 youth and young adults where they learn basic work ethics and standards, professionalism and skills necessary for further employment. Participants struggle with poverty and related chronic diseases such as high blood pressure, obesity and diabetes. Participants are given paid internships to grow food and beautify urban areas. The After School Center targets 75-100 children and youth ages 6-14 who need additional support to improve their literacy and math skills. The Center instructs participants in computers, arts & crafts, gardening, sports, and dance. Volunteer tutors from UC Berkeley and other local universities serve as important role models.
