Ross Valley Players (RVP) presents a main season of six major productions performed between July and June of the following calendar year. For fiscal year 7/1/17 thru 6/30/18 there were 24 performances of "The 39 Steps", 20 performances of "Cabaret", 19 performances of "The Game's Afoot", and 16 performances each of "The Children's Hour", "Dead Man's Cell Phone", and "The Tin Woman". The total number of performances equal 111. The audience breakdown varies from one production to another based on the particular play, including such factors as play name recognition, the subject matter and content, whether the play is a classic or a new script, and whether the playwright is well known. The attendance for the six productions was about 9,260 plus 560 volunteers. Audiences varied between 2445 for "Cabaret" and 900 for "The Tin Woman". Ticket categories included general admission, subscribers, and greatly reduced prices for those under age 25. The productions can include students in acting roles as well as in technician assignments. Having students and those under age 25 involved in productions helps RVP to accomplish an important part of its mission to provide an open, collaborative environment in which to learn and develop theater crafts.

"The second largest activity is RVP's RAW Festival (RAW = RossAlternative Works) In addition, RAW had two staged readings of newplays by San Francisco Bay Area playwrights who have written a play that has not yet been produced and which may still be a work in progress In July, 2009, RVP decided to improve the presentation of such new works from a staged reading to a full production with memorization of the script, stage movement, costumes, stage lighting, and sound effects The intent was to provide audiences with a more complete presentation and to provide the playwright with the opportunity to see and hear a more complete production of his or her creative work in front of live audiences and to receive their immediate feedback in talkback sessions This fiscal year there was one full production of a new musical "Just My Type" The production had ten performances and an audience of 971 plus 50 volunteers We often include students in both acting roles and in technical assignments In addition, Raw had two staged reading of new play - one each night of "Beyond Measure" and "Ricochet" to provide audience feedback to the playwright An audience of about 40 attended each of the two stages readings and participated in the talk back Total audience for "Just My Type" and the two staged readings in the raw season was 1051 plus 60 volunteers Additionally, raw produced a staged reading in October, 2017 of a new play "Surprise Party" with an audience about 45 patrons plus 5 volunteers
