Coordinated Entry System (CES) - BFHP serves as the single point of entry for all homeless men and women seeking city-funded services. Through this program, BFHP is able to assess the needs of the individual, give priority to the disabled and chronically homeless, and offer not only BFHP's programmatic services, but also services offered by other associated agencies. Services offered may address shelter, transitional housing, permanent housing, employment, social security advocacy, mental and medical health, money management, domestic violence, senior and veteran's support services, etc. The CES program maximizes the available resources in the community in an effort to ease the crisis of homelessness

4b (Code) (Expenses \$ 1,973,853 including grants of \$) (Revenue \$)

Roads Home (RH) - Through an internally designed innovative peer outreach program, BFHP engages with and delivers rapid rehousing and employment services to homeless veterans over a three county area (Alameda, Contra Costa, Solano)

4c (Code) (Expenses \$ 1,069,130 including grants of \$) (Revenue \$ 37,665)

North County Women's Center (NCWC) - This comprehensive three-story service center includes three interconnecting programming components, each of which is responsive to the unique and complex needs of the most vulnerable of homeless sub-populations: women and children. These components include a 32 bed emergency shelter, 23 bed transitional housing program for disabled women and children, a 2 bed medical respite program for homeless women being discharged from inpatient care. NCWC's supportive services include housing case management, life skills training, basic financial literacy education and budgeting assistance, meals, laundry, restroom and shower facilities, onsite access to primary medical and women's health services, employment assistance, and linkages to a robust network of collaborating agencies
