A legal advocate assists clients with completing paperwork for divorces and child custody cases and individual counseling is available as well.

Prevention & Education Services - Crisis Intervention Services dba Tahoe Safe Alliance's philosophy is that all people have the right to a life without violence, and they believe the best time to stop violence is before it begins. The prevention program provides prevention education to children and teens in schools and in the community. The prevention program provides violence prevention education in English and Spanish to local school districts, businesses, and organizations in North Lake Tahoe and Truckee.
