AiA empowers students to develop creativity, critical thinking, and complex problem solving, through hands-on learning with art. In addition to the aforementioned skills, hands-on learning through arts education has been shown to positively affect student content knowledge, create high levels of engagement, and improve skills in collaboration. AiA ignites children's imaginations to become innovators, creators, and leaders preparing them for the jobs of tomorrow.
