The agency's main campus, located on 17 acres of park-like grounds, includes five cottages, developing a student center for arts, children's resource center, nursing offices for children and families, a playground, swimming pool, and a child-friendly library. We also strive to reunite children with their biological family, guardians, anyone that is invested and capable of taking care of children. With input from children and families, Hillsides partners with other agencies and resources to provide them with the highest quality continuum of care and ensure they reach their full potential. For this fiscal period, 116 clients and 318 family members were serviced.
