Through an education that is rooted in the liberal arts tradition, students choose from among 30 majors and 30 minors, or create their own interdisciplinary major through the Whittier Scholars Program. While here, students have a breadth of assistance available to ensure academic success at all levels. Resources and programs include faculty advising; peer tutoring; basic and advanced skills training in the Writing Center; library and information technology instruction; computer labs smart classrooms, and campus-wide WiFi; mentoring programs; assessment; and an early warning system to identify students who may be experiencing temporary difficulty in the classroom. Additionally, a formal program targeting the first-year encompasses a comprehensive support system, with required "living-learning communities," specialized seminars, and linked and paired courses which emphasize interdisciplinary connections.
