Pt VI, Line 12c: The Board of Trustees monitors compliance of the conflict of interest policy annually with existing Trustees and upon appointment of new Trustees.

Pt VI, Line 15a: The Compensation Committee of the Board of Trustees considers comparative industry data and data collected through the National Association of Independent Schools when reviewing, changing or implementing the compensation plan or agreement for the Head of School.

Pt VI, Line 11b: The School's management and Finance Committee of the Board of Trustees reviews and approves the Form 990.
