North Hawaii Community Hospital recognizes the importance of these needs and has supported efforts to address many of them, it is also recognized that there are health needs that NHCH will not directly be addressing due to resource constraints. One of the major themes presented in the 2015-2016 report is "Access to Care." Hawaii County has significant unmet healthcare access needs due to provider shortages, limited oral health services and coverage, and inadequate coordination in mental health care. Residents also face substantial rates of poverty and challenges in transportation, further exacerbating access issues. To address this need, NHCHs goal is to promote and improve access to care for the people of Hawaii, specifically Hawaii Island, through outreach to underserved families, education, technology, and physician recruitment in the areas of primary care, OB/GYN, and general surgery through the following objectives: 1. Improve access to underserved populations by increasing the number of new patients and decreasing wait time for first appointments. 2. Increase physician recruiting, specifically for primary care, OB/GYN and general surgery. 3. Shorten the length of time between diagnosis of cancer and initiation of treatment. 4. Increase translation services to improve cultural competency and to strengthen care. In the fiscal year ended June 30, 2018, NHCH continued to recruit physicians in the areas of primary care, orthopedic, and OB/GYN and plans to continue its efforts to hire quality health care providers in the identified areas. Going forward, NHCH will continue to work on the other objectives identified in its Implementation Strategy. Although NHCH will not directly be addressing all of the areas of need listed on the CHNA report, we have supported and partnered with others to address several of them and will continue to support opportunities to address community health needs in collaboration with others.
