A major continuing objective of Community Advance is to provide programs that significantly advance the life-skills of students. We provide a mentoring program ("The Club") for Middle School students (6th-8th grade) attending nearby community public schools. A majority of those attending these schools are Hispanic or Black students, with a significant proportion underperforming in mathematics and reading, from single-parent families, have a high dropout rate, and essentially all are eligible for free or reduced priced lunches. The weekly after-school "Club" sessions throughout the school year include a life skills training topic (presented by invited community leaders), a Biblical focus topic to encourage character and moral values development, and participation in one of several structured elective activities. Student interaction with adult leadership in each of these activities is encouraged by staff and volunteer adult mentors. Planned occasions to interact with the parent(s)/guardian(s) of the students is a priority objective. The enrollment has grown to exceed 100 students. The Club curriculum has been expanded to encourage each student to participation spanning the 3 middle-school years, with the continuing focus each year on career exploration tailored to the individual student. In addition to the two regular semester sessions each year, a six-week summer session ("The Summer Club") is also offered with half-day programs five days per week; enrollment now exceeds 120 students.

Our computer learning center is currently equipped with 18 computers with individual audio headsets. Our goal is to add additional units to provide a total of 24 computer stations. We have recently added a smartboard to the available facilities in this center, which has assisted materially in the instructional capabilities. This facility provides the Club students with Internet access to implement the curriculum developed for career exploration, as well as assist student participation in other Community Advance elective projects

4c (Code:) (Expenses \$ 11,364 including grants of \$) (Revenue \$)

Community Advance has established an annual scholarship program providing two Northwest Classen High School graduates funding for up to four years to pay approved college expenses (up to \$2,500 per academic year) while attending any accredited college or university in the State of Oklahoma. The first two scholarship awardees were selected in the Spring of 2014. Awardees may request the Scholarship Committee to defer activation of payments from this source for up to two years. In addition, individual awardees who have an alternative source of funding to pay tuition or other educational costs may request that payments from this scholarship integrate with their funding from alternative source(s). This scholarship program is underwritten by endowment funds contributed as a designated memorial. Payments of approved educational expense items are made by checks issued directly to the educational institution or other vendor.
