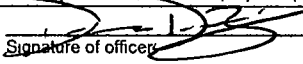

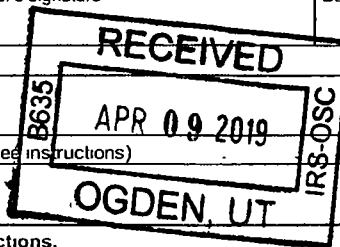

The Chairman and the Secretary conduct a written review of the President

prior to the end of the fiscal year, then meet with the President in person

to share feedback and address concerns. The President also completes

a written self-assessment which contributes to the Chairman's and

Secretary's review. An executive session is held at the board meeting to

approve a compensation package for the President. A new employment

agreement is then executed by the Chairman and President.
