Explanation: The volunteer board of directors is made up of parents of students at the high school, none of whom have experience with tax matters outside of filing personal income tax. We believe the organization has reasonable cause for late filing as they exercised ordinary business care and prudence with the knowledge they had and were not willfully neglecting their reporting obligations.
